PUBLIC NOTICE

It is brought to the notice of all concerned that M/s MEGHALAYA CEMENT LTD. has proposed to set up a Limestone Mine over an area of 33.45 Ha. at Thangskai, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

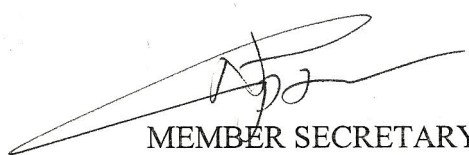
