PUBLIC NOTICE

It is brought to the notice of all concerned that **WAHRIANG LIMESTONE MINE** has proposed Limestone Mine over an area of 1.33Ha. located at Wahriang, Khliehshnong, Elaka Rymbai, East Jaintia Hills District. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the provisions of Para 7(i) III of the above Notification, the Deputy Commissioner, East Jaintia Hills District, Khliehriat has vide letter No. EJHD/Rev-331/2023/5, Dated 26th September 2023 fixed the date of the **PUBLIC HEARING** to be held at **WAHRIANG, KHLIEHSHNONG, ELAKA RYMBAI, EAST JAINTIA HILLS DISTRICT** on the **08th November 2023 at 11.00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
